ORDER

This Writ Petition had been filed challenging the impugned demand of the second respondent dated 15.06.2017, and to quash the same by allowing the above writ petition.

2. The order impugned herein is an order appealable under the Provisions of Regulation 11 of the Tamil Nadu Electricity Supply Code 2004. In view of the same, the Writ Petition is disposed of with a liberty to the petitioner to approach the Appellate Authority available under the Regulation 11 of the Tamil Nadu Electricity Supply Code on or before 30.12.2024.

3. If any appeal is filed within the said date, the Appellant Authority shall not insist upon the issue of limitation in entertaining the appeal filed by the
