classified as a pathway and there is no possibility of converting the same into natham land and to grant patta and he has also relied on the report of the Village Administrative Officer, Sammanthapuram.

4.In the event it is not possible for grant of patta, the respondents shall pass orders on the petitioner's representation dated 22.09.2015 on merits and communicate the same to the petitioner to work out his remedy in the manner known to law.

5.This writ petition is disposed of in the above terms. No costs. Consequently connected miscellaneous petition is closed.
