ORDER

The present Writ Petition has been filed by an Assistant Manager of the respondent Transport Corporation, who retired from service on 31.12.2022 seeking a Mandamus for payment interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, the terminal benefits were released 22 months after the date of retirement. Hence, the petitioner has addressed a communication to the respondents on 02.11.2024 seeking payment of interest for the belated disbursement of terminal benefits. Since there is no response, the present writ petition has been filed.
