The learned Government Advocate (Crl.side), on instructions, submitted that case has been registered against the petitioner and one Muniyaraj, on 28.11.2024, in Crime No.409 of 2024 for the offences under Sections 296(b), 329(2), 115(2) and 351(2) of BNS and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.

3. In view of the above, nothing survives for further adjudication in this case. Accordingly, this Criminal Original Petition is closed.
