ORDER

The present Writ Petition is filed challenging the impugned order passed by the third respondent dated 30.10.2024 and further direct the third respondent to consider the building plan application dated 24.06.2024 on merits.

2. Under Section 133(10) of the Tamil Nadu Urban Local Bodies Act, 1998, an appeal lies against the order passed by the Commissioner of the Municipality.
