PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the impugned para 38 of audit objections in letter Na.Ka.No.242/A1/2024, dated 31.05.2024 issued by the third respondent for recovery of Rs.1,53,623/- (One Lakh Fifty Three Thousand Six Hundred and Twenty Three only) and quash the same and consequently direct the respondents to grant the pay fixation done as per G.O.Ms.No.340, Finance Department dated 26.08.2010 together with interest at the rate of 24% p.a. From 01.05.2024 till the date of realization.
