Prayer: Petition filed under Article 226 of the Constitution of India, praying for issuance of Writ of Mandamus, directing the third respondent to accept the proposal of exchange of land for enabling the access (ingress and egress) to the petitioner's land comprised in S.Nos.135/1, 135/2, 138/5, 138/7 and 138/8 as pathway to reach the public approach road by providing as part of Government Anadheenam land to an extent of 7mt width 8 cents comprised in S.Nos.138/6 and 138/9 situated at Kurukkalpatti Village, Tenkasi District, vide an exchanging/alternate the petitioner's land to an extent of 8 cents comprised in S.No.138/7, which is abetting to the Government Anadheenam land by considering the petitioner's representation dated 16.10.2024 and pass appropriate orders within a time to be stipulated by this Court.
