No. 55 of 2023 on the file of the Learned Special Court for Trial of SC/ST Cases, Pudukottai by considering the petitioner representation dated 28.09.2024 in the light of the Rules 4(5) (6) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Amendment Rules, 2016 within a definite stipulated time that may be fixed by this Honble Court.
