2.This writ petition has been filed for a Mandamus to grant extension of time for further period of one month in I.A.No. 3316 of 2024 in S.A.No.654 of 2024, enabling the petitioner to pay the first instalment amount.

3.Since an effective remedy lies before the Debts Recovery Tribunal, invoking the jurisdiction of this Court under Article 226 of the Constitution of India would not be permissible and hence, the Writ Petition stands dismissed, with liberty to the
