ORDER

This Writ Petition is filed for issuance of writ of mandamus directing the respondent No.4 to consider the petitioner's representation and objection dated 24.10.2024 and to pass orders relating to issuance of patta in S.No.968/2B2 of Viralipatti Village, Nilakkottai Taluk, Dindigul District.

2. With the consent of both parties, this Writ Petition is taken up for final disposal at the stage of admission itself.

3. The petitioner made a representation on 24.10.2024 objecting to the application made by the sixth respondent for grant of patta in his favour. As the petitioner's representation was not considered, the petitioner has filed the above Writ Petition for the aforesaid relief.
