PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to settle the petitioner surrender leave salary for 135 days in respect of the years 2010-2011, 2011-2012, 2012 – 2013, 2013 – 2014, 2014 – 2015, 2015 – 2016, 2016 – 2017, 2017 – 2018, 2018 – 2019, 2019 – 2020, 2020 – 2021, 2021 – 2022 and 2022 - 2023 together with interest at the rate of 18% per annum payable from the date for retirement to till the date of actual payment.

ORDER

The present Writ Petition has been filed by a retired Special Grade Tradesman of the respondent Transport Corporation, seeking disbursement of the surrender leave salary along with interest.

Since the representation has not been considered, the present writ petition has been filed.

Considering the above said facts, the respondents herein are directed to release the eligible surrender leave salary to the writ petitioner along with interest at the rate of 6% p.a., from the due date till the date of disbursement, within a period of twelve weeks from the date of receipt of a copy of this order.
