3.The learned Government Advocate (Crl. side) submits that the festival is over and therefore, the relief sought for in this petition has become infructuous.

4.The allegation made by the petitioner is of an excommunication, which cannot be permitted at any cost. Therefore, this writ petition is disposed of with a direction to the fifth respondent/Tahsildar to find out if there is any practice of
