PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to pay interest at the rate of 6% per annum to the petitioner for the belated payment of Gratuity, Provident Fund, Leave Salary and Pension Commutation from the date of retirement to the date of actual payment.

ORDER

The instant writ petition has been filed by a retired employee of the respondent Transport Corporation, seeking a mandamus directing the respondents to pay interest at the rate of 6% per annum for the belated payment of petitioner's terminal benefits.

2. According to the learned Counsel appearing for the writ petitioner, the petitioner was appointed in the respondent Transport Corporation on 02.11.1998 and he had attained superannuation on 31.12.2022. The terminal benefits were disbursed belatedly to the writ petitioner only on 30.10.2024. Hence, he sent a representation on 08.11.2024, seeking interest for the belated payment. Since, there is no response from the respondents authorities, the present writ petition has been filed.
