Criminal Miscellaneous Petition filed praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to direct the respondents to temporarily release the detenu by name Kingslin, S/o. Anthony Kitheriyan aged about 29 years, now detained as Goonda at Palayamkottai Central Prison under preventive detention by order passed by the Respondent No.2, vide his order in M.H.S.Confdl.No: 100/2024 dated 09.06.2024 under section 3(1) of Act 14 of 1982, for 3 days to attend the funeral ceremonies of the sister of the detenu by name Jarlin Mysgat.

Prayer in Habeas Corpus Petition(MD) No. . 865/ 2024 :

Petition praying that in the circumstances stated therein and in the affidavit filed therewith, the High Court will be pleased H2-GO. To detention order of the R2 in M.H.S,Confdl No.100/2024 dated 09.06.2024 and Quash the same and direct the Respondents to produce the body or person of the detenu by name Kingslin, S/o. Antony Kitheriyan, aged about 30 years, detained as Goonda at Palayamkottai Central Prison before this Honorable Court and set him at liberty forthwith.
