2. The petitioner is the accused in C.C.No.191 of 2022 on the file of the Fast Track (Judicial Magistrate Level) Court, Tuticorin. The petitioner has filed a petition under Section 254 (2) in Cr.M.P.No.6905 of 2023 before the learned Judicial Magistrate/Fast Track Court, Tuticorin to examine the defence side witnesses and the same was dismissed on 16.10.2023.
