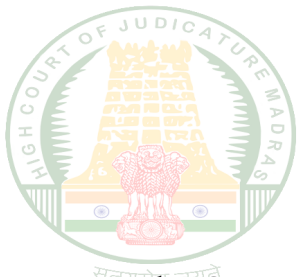

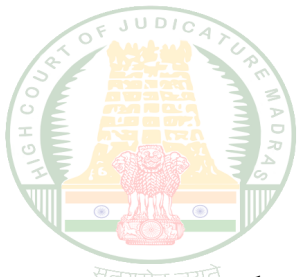
Prayer :-

2. The learned counsel appearing for the petitioner submits that in the writ

petition, the petitioner has filed an amendment petition along with the original rejection order dated 21.02.2024 passed by the respondent. However, based on the submission that the petitioner's application dated 23.02.2022 was rejected by the respondent, this Court, by order dated 08.03.2024, closed the writ petition with liberty to the petitioner to challenge the rejection order passed by the respondent in the manner known to law, even before the amendment petition was numbered.

3. Since the writ petition was disposed of, the petitioner requires the original rejection order dated 21.02.2024, which has already been filed along with the amendment petition in W.M.P.(MD)No.5470 of 2024.

4. Therefore, the Registry is directed to return the original rejection order dated 21.02.2024 to the petitioner, by today itself.
