Order : This criminal miscellaneous petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/s.K.SUYAMBULINGABHARATHI, Advocate for the petitioner and of Mr.M.SAKTHI KUMAR, Government Advocate (Crl. side) on behalf of the Respondent Nos.1 and 2, the Court made the following order:-

This Criminal Miscellaneous Petition has been filed to relax the condition imposed on the petitioners to appear before Inspector of Police, Thirumangalam Police Station, Chennai daily at 07.30 pm., in Crl.A.(MD).No.791 of 2024 on 04.10.2024 in connection with the Crime No.224 of 2023.
