ORDER

The present Writ Petition has been filed by a retired Special Grade Conductor of the respondent Transport Corporation, seeking disbursement of the surrender leave salary along with interest.

2. Though the petitioner has retired from service on 31.03.2023, the surrender leave salary has not been disbursed to the writ petitioner, despite giving representation to the respondents on 13.11.2024, for disbursing the said benefits. Since the representation has not been considered, the present writ petition has been filed.
