**ORDER**

This Writ Petition is filed, seeking to direct the respondents to issue equivalence certificate for the petitioner's qualification of B.Sc., B.Ed., integrated four years program conducted by the 2<sup>nd</sup> respondent as equivalent to B.Sc., (Botany) B.Ed., so as enable the petitioner to get appointment, by considering the petitioner representation dated 12.08.2024.

2.Heard the learned counsel appearing for the petitioner, the learned Government Advocate appearing for the respondents 1 and 3, the learned Deputy Solicitor General appearing for the 2<sup>nd</sup> respondent and carefully perused the entire materials available on record.

3.The petitioner has completed B.Sc., (Botany), B.Ed., integrated four year programme conducted by the second respondent requiring to issue a equivalence certificate to the same as equivalent to B.Sc., (Botany), B.Ed.
