PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to pay interest on the delayed payment of retirement benefits paid to the petitioner, from the date of his retirement i.e., 31.01.2023 to actual payment made on 30.10.2024, in view of the Hon'ble High Court orders and the petitioner's representation dated 10.11.2024.

ORDER

The instant writ petition has been filed by a retired employee of the respondent Transport Corporation, seeking a mandamus directing the respondents to pay interest at the rate of 6% per annum for the belated payment of petitioner's terminal benefits.

2. According to the learned Counsel appearing for the writ petitioner, the petitioner was appointed in the respondent Transport Corporation in the year 1999 and he had attained superannuation on 31.01.2023. The terminal benefits were disbursed belatedly to the writ petitioner only on 30.10.2024. Hence, he sent a representation on 10.11.2024, seeking interest for the belated payment. Since, there is no response from the respondents authorities, the present writ petition has been filed.
