PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents 1, 2 and 3 to settle the petitioner's surrender leave salary so far not given by the respondent Corporation for 98 days for the value of Rs.79,066.00/- (Rupees Seventy Nine Thousand and Sixty Six only) in respect of the years 2011 to 2023 together with interest at the rate of 18% per annum payable from the date for retirement to till the date of actual payment.

ORDER

The present Writ Petition has been filed by a retired Special Grade Driver of the respondent Transport Corporation, seeking disbursement of the surrender leave salary along with interest.

2. Though the petitioner has retired from service on 28.02.2023, the surrender leave salary has not been disbursed to the writ petitioner, despite giving representation to the respondents on 06.11.2024, for disbursing the said benefits. Since the representation has not been considered, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.

4. Considering the above said facts, the respondents herein are directed to release the eligible surrender leave salary to the writ petitioner along with

interest at the rate of 6% p.a., from the due date till the date of disbursement, within a period of twelve weeks from the date of receipt of a copy of this order.

5. With the above said observations, this Writ Petition stands disposed of. There shall be no order as to costs.
