2. The above said suit was filed by the respondent / plaintiff for partition and the same was decreed ex parte on 10.02.2020. Thereafter, the respondents / defendants filed I.A.No.79 of 2021 seeking to restore the above said suit and the same was dismissed by the trial Court on 10.03.2023.
