PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to pay the petitioner, difference amounts in gratuity, leave salary, Commuted Value of Pension, difference in pension from 01.04.2017 to 25.02.2019 and family pension arrears from 26.02.2019 to till date along with Dearness Allowance on par

with serving employees of Transport Corporation based on such revised wages payable to the petitioner's husband as on the date of her husband M.Ramaraj's retirement that is 31.03.2017 in terms of the wage revision settlement under Section 12(3) of I.D Act dated 04.01.2018 along with interest at the rate of 6% per annum.

ORDER

The instant writ petition has been filed by the wife the deceased employee seeking a mandamus to disburse the terminal benefits arising out of 12(3) wage settlement dated 04.01.2018.

2. According to the learned Counsel appearing for the writ petitioner, the petitioner's husband was working as Traffic Inspector in the respondent Transport Corporation and he had attained superannuation on 31.03.2017. The petitioner's husband was died on 25.02.2019. He further contended that the 12(3) Wage Settlement was arrived on 04.01.2018, and the pay of all Transport Corporation employees were revised retrospectively from

01.09.2016. The petitioner's husband is eligible to receive benefits under the 12(3) wage settlement dated 04.01.2018, and he is eligible to receive the said benefits and for revision of his pensionary benefits.

3.The petitioner has sent a representation to the said effect on 15.07.2024. Since, there is no response from the respondents, the present writ petition has been filed.

4. Considering the above said facts, the respondent Transport Corporation is directed to disburse the eligible terminal benefits arising out of 12(3) wage settlement dated 04.01.2018 to the writ petitioner along with 6% interest from the due date till the date of disbursement within a period of twelve (12) weeks from the date of receipt of a receipt of a copy of this order.

5.With the above said observations, this writ petition stands disposed of. No costs.
