5.The learned counsel for the 2nd respondent submitted that as far as the petitioner's request for a drinking water connection is concerned in the forthcoming financial year, that is, 2024-25, a final decision will be taken on providing separate tap facilities to the residents of Gandhi Nagar. Whenever a final decision in this regard is taken, the petitioner will be duly provided with drinking water connection.
