On receipt of the same, the first respondent and its committee pass orders on the request made by the petitioner on merits and in accordance with law based on the report submitted by the third respondent within a period of eight weeks, thereafter.

5. With the above direction, the writ petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
