ORDER

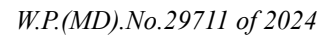
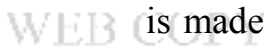

By consent of both sides, the Writ Petition is taken up for final disposal at the stage of admission itself.

2. This Writ Petition has been filed for a Mandamus to direct the respondents 4, 6 to 8 to restore the Vari in S.Nos.190/1, 190/8A, 190/9, 190/10B, 190/11, 190/11B, Mathur Village, Kulathur Taluk, Pudukkottai District by cancelling the order of assignment patta and sale deed executed among respondents 9 to 13 as Government Poromboke land.

3. Since no adverse orders are going to be passed against the respondents 9 to 13, notice to the respondents 9 to 13 is hereby dispensed with.

4. The petitioner herein had given a representation to the official respondents on 02.08.2024 to restore the Vari in the aforesaid lands by cancelling the order of assignment patta and sale deed executed among respondents 9 to 13 as Government Poromboke land. Since the said representation was not considered, the present Writ Petition has been filed.



6. In the light of the above observations, there shall be a direction to the respondents 1 to 8 herein to consider the petitioner's representation dated 02.08.2024, on its own merits and pass appropriate orders in accordance with law, after giving due opportunity to the petitioner and the respondents 9 to 13, as well as all other persons, who may be interested in the subject matter, within a period of three (3) months from the date of receipt of a copy of this order. It is made clear that this Court has not expressed any of its views with regard to the merits of the matter and that it is open to the concerned respondents to consider the same on its own merits.
