2.Originally the suit was filed by the first respondent before the District Munsif Court, Theni, seeking declaration and consequential permanent injunction in respect of the list of properties mentioned in the plaint schedule. Thereafter as per the order of the Principal District Judge, Theni, it was transferred to the Court of Principal District Judge, Theni and renumbered as O.S.No.121 of 2021. The grievance of the petitioner is that he is the third defendant in the suit and though the suit was filed in the year 2020, it was not disposed of till now.
