2.The case of the prosecution is that the petitioner herein is the accused No.3 and on 07.11.2023, when search was made by the respondent police, they caught A-1, who was in possession of 4 kgs of Ganja, which was allegedly purchased from the petitioner herein and the same was recovered under a cover of mahazar. Hence, the complaint.

3.The learned counsel for the petitioner would submit that the petitioner is an innocent person and he is no way connected with the alleged offence and therefore, prays for grant of anticipatory bail.

4.The learned Additional Public Prosecutor strongly objected this petition for grant of anticipatory bail by stating that the petitioner has three previous cases of similar nature.

5. Considering the facts and circumstances of the case and considering the previous antecedent of the petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this petition is dismissed.
