The learned counsel appearing for the petitioner would aver, among other things, that the respondent filed H.M.O.P.No.169 of 2023 on the file of the Family Court, Karur, for dissolution of marriage. The petitioner submits that distance between the residence of the petitioner to Karur is 140 kms and therefore, she is not in a position to travel and seeks for transfer.

3. Heard the learned counsel for the petitioner and perused the materials placed on record. Though the name of the respondent is printed in the cause, none appears for him.

4. I am satisfied with the reasons stated in the affidavit filed in support of this petition. It is well settled law that convenience of woman is to be taken into consideration at the time of considering transfer applications as held by the Supreme Court in the judgment reported in **2008(9)SCC 353 (Arti Rani @ Pinki Devi and another Vs. Dharmendra Kumar Gupta)**. I am inclined to allow this Transfer Civil Miscellaneous Petition. Accordingly, this
