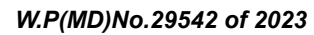

I respectfully state that the 3rd Respondent has taken all the strenuous steps to get the sanction from the 1st Respondent for the refund of I&A Charges, shelter fund and centage charges and accordingly proposal was sent through the 2nd Respondent to the 1st Respondent.
