This Writ Appeal is directed against the order dated 27.09.2023 made in W.P.(MD)No.20264 of 2023 on the file of this Court.

2.Mr.N.Satheesh Kumar, learned Additional Government Pleader appearing for the appellants has submitted that in connected Writ Appeal in W.A.(MD)No.414 of 2024, vide order dated 19.03.2024, this Court removed the cost imposed on the appellant Department and since the issue involved in this appeal is squarely covered by the said decision, the same relief may be extended to this case also.

3.The learned counsel appearing for the respondent has no objection for setting aside the cost imposed by the Writ Court.
