3.The learned counsel for the petitioner would submit that the petitioner is an innocent person and he is no way connected with the alleged offence and therefore, prays for grant of anticipatory bail.

4.The learned Additional Public Prosecutor strongly objected this petition for grant of anticipatory bail by stating that the petitioner has two previous cases of similar nature.

5. Considering the facts and circumstances of the case and considering the previous antecedents of the petitioner, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, this petition is dismissed.
