Pleaded to set aside the Order dated 02.09.2022 in WP(MD)No.5921 of 2021 on the file of this Hon'ble Court.

Prayer in WP(MD). 5921/ 2021 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF CERTIORARIFIED MANDAMUS or any other writ, ordirection, in the nature of writ or call for the records in respect of order passed by 3rd respondent in O.Mu.No.1098/Aa1/2020 dated 04.09.2020 and quash the same and consequently direct the 2nd and 3rd Respondent to approve the appointment of the petitioner and disburse all the service and monetary benefits from the date of the appointment (ie.,03.06.2019) and pass such further of orders as this Honourable Court may deem fit and proper in the circumstances of the case and thus render justice.
