ORDER

This Criminal Original Petition has been filed to set aside the order passed in

Cr.M.P.No.3987 of 2023 dated 08.11.2023 by the learned Principal Sessions Judge,

Theni and consequently, totally relax the condition imposed on the petitioners.

2.The learned counsel appearing for the petitioners would submit that the petitioners are accused in Cr.No.342 of 2023, which was registered for the offence punishable under Sections 341, 147, 148, 294(b), 323, 324, 307 and 109 IPC and thereafter, they were arrested by the law enforcing agency. Hence, they filed bail petition before the Court below in Cr.M.P.No.3406 of 2023 and the same was allowed on 27.09.2023 on condition that the petitioners should stay at Dindigul and sign before the Inspector of Police, Dindigul Town Police Station, Dindigul District daily at 10.30 am., and 05.00 pm., until further orders. He would further submit that the petitioners filed relaxation petition before the learned Principal Sessions Judge, Theni in Crl.M.P.No.3987 of 2023 and the learned Judge modified the condition that the petitioners should respond to police once in a month ie., on first Sunday of every month at 10.30 am., until further orders. He would also submit that the petitioners herein are employees of TNSSTC and hence, they are unable to comply with the condition. That apart, due to the condition, the employer has not given job to the petitioners and they seek total relaxation of the condition. The petitioners herein are the bread-winners of their respective family and hence, he would pray to relax the condition.

3.The learned Government Advocate(Crl.side) appearing for the respondent

police would submit that the Court below, after considering all aspects, correctly imposed the condition, which does not warrant any interference by this Court.

4.Considering the facts and circumstances of the case and considering the fact that the petitioners are employees in TNSSTC, the condition imposed by the Court below is fully relaxed and the petitioners shall report before the respondent police as and when required. Accordingly, this criminal original petition is allowed.
