## **ORDER**

2. The grievance of the petitioner is that a document was sought to be produced by the respondent herein before the trial Court and that was also marked as Ex.B6. He would submit that it is a xerox copy of the unregistered sale agreement dated 31.01.2013, entered into between the plaintiff and defendant. 3. It appears that without complying the formalities, the above said document has been produced, accepted and also marked before the trial Court.
