2.Both parties are present and they accepted the lower Court order in I.D.O.P.No.48 of 2021 except Clause 3 & 5. Accordingly, the Clause 3 & 5 of the lower Court order passed in I.D.O.P.No.48 of 2021, dated 12.06.2023 is hereby set aside and the clauses remain unaltered.
