2.The learned counsel for the Petitioner submitted that the Petitioner sought permission for renewal of the licence of spa. The same was not considered by the Respondents. Therefore, he had approached this Court by filing this Writ Petition (W.P.(MD) No.31257 of 2023).

3.By way of reply, the learned Additional Public Prosecutor submitted that in the Tamil nadu Government Gazette Extraordinary, directions were issued to the Authorities concerned for grant of licence or renewal of licence. 4.Recording the submission of the learned Additional Public Prosecutor, the Respondents are directed to dispose of the Petitioner's petition favorably within the reasonable period of two months from the date of receipt of a copy of this order.
