To set aside the decree and judgment of the Principal Subordinate Judge, Kumbakonam passed in A.S.No.136 of 2002 dated 11.04.2003 confirming the decree and judgment of the District Munsif cum Judicial Magistrate, Papanasam passed in O.S.No.135 of 1997 dated 15.03.2002.

ORDER : This Civil Miscellaneous Petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of MR.K.VIJAYARAGHAVAN, Advocate for the petitioner, the court made the following order:-

The Petitioners seek for an order of injunction restraining the respondents from alienating the subject-matter property of the suit in O.S.No.135 of 1997, on the file of District Munsif-cum-Judicial Magistrate Court, Papanasam, pending disposal of the above appeal.

2.It is seen from the records that there is no interim order for the past 20 years.
