The appellant claims himself as the adopted son of the deceased Singaperumal, who is the husband of the writ petitioner/first respondent herein. According to the appellant, the writ petition in W.P(MD)No.4140 of 2017 was filed by the first respondent/writ petitioner without made him as a party. Further, he stated that the writ petitioner has suppressed the fact that she had obtained a decree of divorce from the said Singaperumal and the deceased is the paternal uncle of the appellant and also he has obtained a legal heir certificate from the second respondent.
