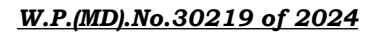
PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to settle the petitioner's benefits of encashment of Earned Leave (45 days) surrendered by petitioner's before the respondents from the year 2010 to till the date of retirement of the petitioner with interest at 6% as per the 1998 wage settlement effect under Section 12(3) of ID Act, 1947.
