Having regard to the limited scope of prayer, that is now sought before this Court by the learned Counsel for the petitioner, without expressing any opinion on the merits of the petitioner's case, this Court directs the third respondent to hold an enquiry with regard to the entitlement/assignment/grant of patta in favour of the petitioner including the rival claimants/private individuals/Government acquisition, based on the petitioner's representation, dated 19.11.2024 and pass appropriate orders on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order.

5. With the above directions, the Writ Petition is disposed of. No costs.
