PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondent to pay the petitioner interest at the rate of 18% per annum, for the period of delay from 01.02.2023 to 29.10.2024, in paying the amounts paid towards his terminal benefits namely EPF Employee's Contribution, Gratuity and Encashment of Leaves within a time frame as may be fixed by this Court and without affecting his right to claim balance amounts towards those benefits.

ORDER

The present Writ Petition has been filed by a retired Foreman of the respondent Transport Corporation, who applied for voluntary retirement on 31.01.2023 seeking the payment of interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, though the petitioner had voluntarily retired from service on 31.01.2023, the terminal benefits were released only on 30.10.2024. Hence, the petitioner has addressed a communication to the respondent on 05.11.2024, seeking payment of interest for the belated disbursement of terminal benefits. Since there is no response, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondent.

4. Considering the above said facts, the respondent herein is directed to pay the interest at the rate of 6% per annum for the belated disbursement of

terminal benefits from the due date till the date of disbursement, within a period of twelve weeks from the date of receipt of a copy of this order.

5. With the above said observations, this Writ Petition stands disposed of. There shall be no order as to costs.
