Petition under Section 437/439 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to release the petitioner on bail pending investigation, enquiry and trial in Crime No.437/2023 of Asifnagar Police Station, Hyderabad.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri C Sharan Reddy, Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent.

The Court made the following: ORDER

THE HONOURABLE SRI JUSTICE K.SURENDER

CRIMINAL PETITION NO.903 OF 2024

ORDER:

1. This Criminal Petition is filed under Sections 437 and 439 of Code of Criminal Procedure, 1973 (for short "Cr.P.C") seeking regular bail to the petitioner/accused in Crime.No.437 of 2023, on the file of Asifnagar Police Station, Hyderabad, registered for the offences punishable under Sections 498-A and 306 of IPC.
2. Heard learned counsel for the petitioner and learned Additional Public Prosecutor for the respondent-State and perused the record.
3. The petitioner is the sole accused. The allegation against this petitioner is that he was married to the deceased and he was harassing her physically and mentally. On the day she committed suicide, it is alleged that this petitioner started recording the alleged suicide attempt of his wife on phone and ultimately she died by hanging herself.
4. Learned counsel for the petitioner would submit that since the deceased was harassing the petitioner and

threatening him that she would commit suicide, by way of caution, the petitioner had recorded the alleged threats of the deceased.

5. On the other hand, learned Additional Public Prosecutor would submit that the petitioner has recorded suicide of the deceased and in fact the petitioner abetted the deceased to commit suicide.

6. Since the case is under investigation, this Court is not inclined to grant the relief of regular bail at this stage.

7. Accordingly, this Criminal Petition is dismissed. However, the petitioner is at liberty to renew his application for regular bail before the lower Court under changed circumstances. Miscellaneous applications, pending if any, shall stand closed.

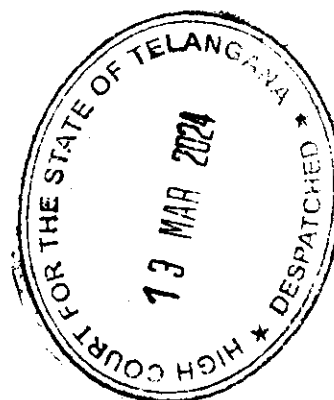
