The present Tax Revision Case is filed by the Department assailing the order, dated 31.03.2008 passed by the Sales Tax Appellate Tribunal, Hyderabad, in T.A.No. 1330 of 2004.

2. *Vide* the said order, the Tribunal has allowed the appeal filed by the assessee, wherein the challenge was to the order passed by the Appellate Deputy Commissioner (CT) in Appeal No.P/363/2003-04.

3. Upon due consideration of the entire facts and circumstances of the case, we do not find any substantial question of law made out by the Department calling for interference with the impugned order passed by the Tribunal. The Tax Revision Case thus fails and is accordingly rejected.
