Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of WRIT OF MANDAMUS by declaring in actions of the official Respondents No.3 and 4 in non-disposal of the Petitioner F-line Application No. DER02200920564 dated 04.12.2023 for conduct the Survey and Boundaries fixation of the agricultural land in Sy. No. 558/1/1/2/3, for an extent of Acres 00-19 gts of Ahmadipur, Gajwel Mandal, Siddipet District, Telangana State, is illegal, irregular, unjustifiable, un-acceptable, unlawful and arbitrary also against the clear violation of Article 14 and 300-A of Constitution India together with violation of Principles of Natural Justice by declaring the Petitioner is entitled to get it survey with fixation of the boundaries for her agricultural land as per the Survey and Boundaries Act, 1923.

WRIT PETITION No.4966 OF 2024

ORDER:

Petitioner submitted F-line application No.DER022300920564 dated 04.12.2023 (sic 12.04.2023) for conducting survey and fixation of boundaries of agricultural land admeasuring Ac.00-19 Gts in Survey No.558/1/1/2/3 situated at Ahmadipur, Gajwel Mandal, Siddipet District.

2. It is stated that the petitioner purchased the aforesaid subject land under registered sale deed bearing document No.2749 of 2022 dated 07.10.2022 and she was issued e-pattadar passbook-cum-tile deed bearing No.T10070041770. Through the aforesaid F-line application, the petitioner requested respondent Nos.3 and 4 to conduct survey and demarcation by fixing boundaries to the subject land, but so far, respondent Nos.3 and 4 did not act upon such application, as such, the petitioner is constrained to approach this Court.

3. Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue, and perused the material available on record.

4. Learned Assistant Government Pleader for Revenue submitted that appropriate action will be taken on F-line application of the petitioner.

5. Recording the above submissions of the learned Assistant Government Pleader for Revenue, without entering into the merits of the case, this writ petition is disposed of directing respondent Nos.3 and 4 to consider the F-line application No.DER022300920564 dated 04.12.2023 (sic 12.04.2023), submitted by the petitioner for conducting survey and fixation of boundaries of agricultural land admeasuring Ac.00-19 Gts in Survey No.558/1/1/2/3 situated at Ahmadipur, Gajwel Mandal, Siddipet District, by issuing notice to the interested/concerned persons, in accordance with law, within a period of forty-five (45) days from the date of receipt of a copy of this order. No order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in this writ petition stand closed.
