Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more particularly one in the nature of writ of mandamus declaring that the action of the 3rd respondent herein in issuing Show Cause Notice of Removal from service of the petitioner is bad arbitrary, illegal and violation of principles of natural justice by setting aside the Show Cause Notice No.01/114(3)/2024-KRTL dt.27-8-2024 of the 3rd respondent herein and consequently direct the respondents to continue the petitioner in service with all benefits by treating the suspension period as on duty for all purposes;
