Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue appropriate writ, order or direction especially one in the nature of a Writ of Mandamus declaring the rejection order vide Roc.No.G1/1648/2019, dated 11.09.2019 issued by the 2nd respondent through which the 2nd respondent rejected permission to the petitioner to erect Telecommunication Infrastructure Tower (TIT) i.e. Roof Top Tower at H.No.6-3-274/I, admeasuring 882 Sq.Yrds., Munur kapu Sangam, near Mutyalapochamma Temple, Jagtiyal, Telangana State as arbitrary, illegal, contrary to law and also the provisions of Municipalities Act and Rules framed there under and against the G.O.Ms.No.96, dated 05.08.2015, Municipal Administration and Urban Development Department, Government of Telangana and in violation of the well settled principles of natural justice consequently set aside the said rejection order issued by the 2nd respondent.
