Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction particularly one in the nature of Writ of Mandamus declaring the impugned action of the Respondents in continuing the disciplinary proceedings after superannuation of the Petitioner w.e.f. 31.5.2009 and not releasing the 240 days earned leave encashment benefit due to the petitioner on his retirement on superannuation as illegal and without jurisdiction and in violation of Articles 14, 16 and 300-A Constitution of India and consequently direct the Respondents to release and pay the 240 days leave encashment amount due to petitioner forthwith with bank rate of interest from the date of fell due to the petitioner.
