Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the 2nd respondent in not passing orders on the application dated Nil-02-2015 made by the petitioner for release of stock of Paddy 2430 Quintals, Rice 255 Quintals and Broken Rice 260 Quintals total worth of goods Rs.38,63,559/- is illegal, arbitrary and violation of principles of natural justice, and consequently direct the Respondent No.2 to release the stock of Paddy 2430 Quintals, Rice 255 Quintals and Broken Rice 260 Quintals total worth of goods Rs.38,63,559/-, on furnishing personal bond for value of the stock by continuing the business.

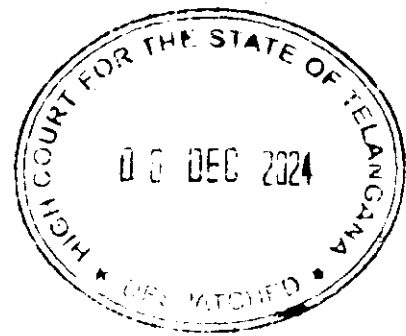
