This Criminal Petition is filed under Section 482 of Code of Criminal Procedure, 1973 (for short "Cr.P.C") by the petitioner-accused No.2 to quash the proceedings against her in C.C.No.826 of 2015 pending on the file of learned Additional Judicial Magistrate of First Class, Karimnagar, filed for the offences punishable under Sections 417, 420 r/w 34 of the Indian Penal Code.

2. None appears on behalf of petitioner. Perused the record.
3. The crime is of the year 2014 and charge sheet was filed in the year 2015. Further, no interim order was passed by this Court stalling the proceedings in the Court below. The stage of the case before the Court below is not known. Therefore, I find no reasons to keep the petition pending and the same is liable to be dismissed.

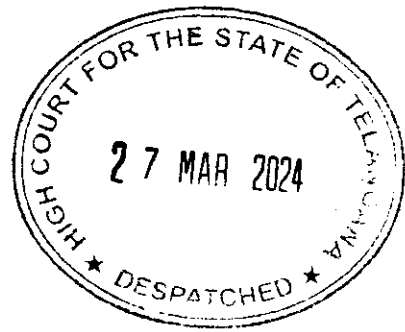
